FACTUAL CIRCUMSTANCES SURROUNDING ARREST OR INCIDENT:

After a vigorous and thorough investigation from the California Highway Patrol a case was submitted to the Mendocino County District Attorney's Office regarding a hit and run on SR-1 at Little Lake Road resulting in the death of Calum Pulido. As a result of the case filed by the California Highway Patrol, two arrest warrants issued on 11/27/19, at approximately 1325 hours. One warrant was issued for the driver in the collision, Gina Rae Bean, and the other warrant was issued for Ricky Santos, who was discovered to be a co-conspirator. CHP Sergeant Margaris, CHP Officers Haury, CHP Officer Doss, and Sergeant Lima of the Mendocino County Sheriff's Office responded to the address of Gina's father in Fort Bragg, where she was not located. After speaking with her father, Officers Haury and Doss responded to Mendocino, located Ricky Santos, and placed him under arrest at approximately 1524 hours. Santos was ultimately transported to Mendocino County Jail and booked. NON-RELEASABLE INFORMATION:

1. Identity of suspect prior to arrest.
2. Results of investigating procedures prior to arrest.
Items 1 & 2 can be released if:
 - will aid in arrest
 - will aid in investigation
 - will warn public of danger
3. Investigative procedures involving officer involved shootings or other personnel actions.
4. Prior criminal record, reputation or character of suspect.
5. Identity of any personal information of a juvenile arrestee or suspect.
6. Confession or existence of a confession.
7. BAC (PAS is releasable).
8. Any photographs except:
 - will aid in arrest
 - will aid in investigation
 - will warn public of danger
9. The identity, credibility, or testimony of prospective witnesses.
10. Any personal opinion as to the suspect's guilt, innocence, or merits of the case.
11. Any information that would be known to be inadmissible in court.
12. References to investigative procedures such as fingerprints, polygraph tests, or ballistic tests.
