24 a FELONY violation of Section 69(a) of the California Penal Code, in that said defendant did

26 officer, to wit, Mendocino County Sheriff's Office Deputy Woida, from performing any duty

2 said officer in the performance of his duty.


3 **STRIKE ALLEGATION**
